Dear Sirs:

The Petersburg community, like many towns in Alaska, is very sensitive to abrupt changes. The loss of a few jobs, an increase in the cost of living, the reduction in local services, all can push us over the edge and into a downward spiral affecting the viability of the community. Governor Dunleavy's proposed budget is not just a "push", but a "SHOVE" in that direction.

As you know, the cornerstone of success in a small town is the combination of our schools, our health care system, our business community, our local government, and our people. The Governor's proposed budget attacks each of these institutions.

For the schools, including early development and the university, a reduction of over \$1.4M in local impact. This will cost jobs, reduce the quality of our educational offerings, the success of our children, and increase taxes on our citizens. For our health care system, the reduction in Medicaid spending, and the WWAMI elimination, will make it more difficult to provide quality health care and recruit the professionals necessary for our success. While the State may pay less in Medicaid, our Hospital, Assisted Living, and other health services will see reduced income without reduced workloads. For our business community, the loss of the ferry system, the harbor facility grant program, the fish taxes (\$867K last year), and the inevitable loss of local spending, will cost jobs. How many commercial or recreational fisherman will buy new gear, new boats, or choose to live in Petersburg if moorage rates must double to support the loss of the fish taxes and maintenance costs of the harbors? For our local government, reductions in areas like the Police Standards Council, the Alaska State Troopers, and Fire and Life Safety programs, make it harder for our Police & Fire Departments to provide a safe community. The loss of public broadcasting makes us less accessible to our citizens and eliminates our only real time communication system for the community.

Last, and most important, the impact on our people is tremendous. Local taxes will go up, our quality of life will go down, and we will see a reduction in our local economy. The loss of the ferries will increase transportation costs and make it harder to live here. The reductions in health care, education and general infrastructure will cost jobs, and increase the cost of living in Petersburg. Quoting one of our multi-generational families, "...if these changes go through, why should I stay in Alaska? It is almost like the Governor wants us all to leave the state."

To summarize, the Petersburg Assembly is adamantly opposed to Governor Dunleavy's proposed budget and encourages the Alaskan Legislature to do everything in their power to support our communities. This includes, a reduced PFD, selective cuts in State expenditures, revised industry tax structure, and a broad-based tax solution.
