At their last meeting, the Local Marijuana Regulation Advisory Committee voted to send a letter to the State Marijuana Control Board requesting municipalities have more local control over the requirement of a 500 foot setback from a school, recreation or youth center, building where religious services are regularly conducted, or a correctional facility. The provision as currently stated exempts most of Petersburg's retail business district from opening a licensed marijuana establishment. Recently, the Sitka Marijuana Advisory Council drafted a resolution requesting the State revise the 500 foot setback to 200 feet, and Sitka's Assembly will be acting on the resolution at their January 12, 2016 meeting. Clerk Thompson drafted Resolution #2016-02, which is similar to Sitka's resolution, with the thought that a Borough resolution may hold more weight with the State Marijuana Control Board than would a letter.
