Tom Abbott, General Manager of KFSK, also spoke in favor of Resolution #2016-4. He read a letter which outlined the services provided by KFSK and shared what cuts public radio received in fiscal year 2016 and those expected in fiscal year 2017. He asked for the Assembly's support of Resolution #2016-4.

The Assembly discussed with Tom Abbott, General Manager of KFSK, the idea of including language in the Resolution regarding the fact that public radio broadcasting had received cuts in fiscal year 2016. Mayor Jensen also expressed his opinion that the Assembly Members attending AML should discuss this matter in more detail with the Legislators. It was agreed that the Resolution would be voted on with the understanding that this language would be added.

Community Development Director Cabrera explained that the amount of land requested in the letter is the average that other boroughs around the state have received in the past through their entitlement program. Assembly Member Lynn stated his opinion that the Borough needs to do more research on the best way to go about obtaining the land. Director Cabrera explained to the Assembly what steps have been taken in the process. There was also discussion concerning whether some of the land listed is eligible for selection.

The Assembly unanimously approved the recommendation.
