Assembly Member Lynn, in his role as liaison to the Hospital Board, shared that he requested the subject of the Hospital Master Planning findings and plans be an agenda discussion item for the joint work session between the Assembly and the Hospital Board that is tenatively scheduled for October.

#### 17. Assembly Discussion Items

#### A. Recognitions

Assembly Member Stanton Gregor recognized all community members who were willing to be a candidate in this year's municipal election. He also encouraged the public to get to know their candidates prior to voting.

Assembly Member Marohl thanked the Fire Department and everyone else who responded to the Motor Pool shop fire recently.

Manager Giesbrecht gave a special shout out to Mike Etcher, who moved the Borough garbage truck that was parked next to the Motor Pool shop and saved the vehicle from being engulfed in the fire. He also thanked all those involved in fighting the fire and updated the Assembly on the inspection by the State Fire Marshal and liability insurance carrier.

Fire/EMS Director Dixson thanked all volunteers of the Fire Department. She shared that EMS and SAR train

at least twice per month and Fire trains at least three times per month. So far in the month of August there have been 18 EMS calls. The Department responded to the Motor Pool shop fire with 3 fire engines, 12 fire fighters (plus 1 retired fire fighter) and 5 EMS personnel. Per protocol, the volunteers spent several hours after the fire was extinguished cleaning equipment and preparing it for the next emergency. Director Dixson also thanked the Police Department for their role in paging out the emergency and evacuating/securing the scene. Community members, Borough employees and volunteers come together to deal with emergencies such as this, but Director Dixson asks us all to remember that the volunteers do it for free.
