Motion was made to amend the proposed FY 2018 budget to remove funding to fill a vacant lineman position for the Electric Department. The motion passed unanimously.

Motion was made to adopt Ordinance #2017-07, as amended. The ordinance was unanimously adopted in its third and final reading.

A motion to reconsider Ordinance #2017-07 was made, and a motion to amend the proposed FY 2018 budget to increase the amount of Secure Rural Schools funds used from \$400,000 to \$540,000 in order to keep the mill rate for education at 4 mills failed by a vote of 3 - 3, Assembly Members Lynn, Stanton Gregor, and Castro in favor.

A second motion to reconsider Ordinance #2017-07 was made, and a motion to amend the proposed FY 2018 budget to move monies budgeted to hire a part-time IT position to Professional Services failed by a vote of 3 - 3, Assembly Members Lynn, Castro and Wohlhueter in favor.
