Ordinances for Third and Final Reading

# A. Ordinance #2020-03: An Ordinance Adopting the Alaska Remote Seller Sales Tax Code and Amending Provisions of Chapter 4.28 for Purposes of Consistency

In 2018, the United States Supreme Court decided South Dakota v. Wayfair, allowing governments to assess sales taxes on remote sales. In December 2019, the Petersburg Borough joined the Alaska Remote Sellers Sales Tax Commission, which is charged with developing and administering a Wayfair-compliant remote sales tax system. On January 6, 2020, the Commission adopted the Uniform Alaska Remote Seller Sales Tax Code, which implements the collection of remote sales tax. Pursuant to its membership agreement with the Commission, the Petersburg Borough is required to adopt the Uniform Remote Sales Tax Code. While the Petersburg Borough's authority to assess, collect, and remit remote sales tax will be delegated to the Commission, the Petersburg Borough retains its authority to establish and modify local sales tax rates and exemptions. Ordinance #2020-03 was unanimously approved in its first and second readings.

Ordinance #2020-04: An Ordinance Amending Petersburg Municipal Code Chapter 3.48 Titled "Parks and Recreation Department" to Reflect Borough Incorporation

If adopted, Ordinance #2020-04 will move Chapter 3.48 from old City Code to Borough Code. Ordinance #2020-04 was unanimously approved in its first and second readings.

C. Ordinance #2020-05: An Ordinance Adopting a new Petersburg Municipal Code Chapter 3.49 Titled "Parks and Recreation Advisory Board"

If adopted, Ordinance #2020-05 will establish a new Parks and Recreation Advisory Board. As written, the ordinance provides for a 5 member elected board. Alternately, the ordinance could be amended to provide for a 5 member appointed board if the Assembly desires. In the case of an appointed board, the Assembly would seek letters of interest and appoint board members. Board member terms would still apply. Ordinance #2020-05 was unanimously approved in its first reading.

During the first reading of Ordinance #2020-05 at the March 2, 2020 Assembly meeting, many Assembly members discussed adding a provision in the ordinance that states the Parks and Recreation Advisory Board will dissolve if no meeting is held during any one year period. Clerk Thompson added that provision under 3.49.050 for the second reading. Ordinance #2020-05 was unanimously approved in its second reading with the amendment.

# D. Ordinance #2020-06: An Ordinance Adjusting the FY 2020 Budget for Known Changes

If approved, Ordinance #2020-06 will amend the FY 2020 Budget to authorize the expenditure of \$72,118 from the Property Development Fund to repair the Aquatic Center Heat Exchanger and Air Handling System, the transfer of \$43,000 from the General Fund to the Parks and Recreation Fund to pay for additional electric and water costs incurred due to a pool leak, and to record a \$464,551 payment from the Borough's liability insurance carrier, APEI, and a possible expenditure to the Motor Pool Design/Construction capital project fund in FY 2020. Ordinance #2020-06 was unanimously approved in its first reading.

A. Ordinance #2020-09: An Emergency Ordinance Amending the FY 2019/2020 Budget to Establish a Local Emergency Disaster Fund and Approve an Emergency Appropriation into the Fund to Respond to the COVID-19 Outbreak

Emergency Ordinance #2020-09, if adopted, will establish a Local Emergency Disaster Fund and approve an emergency appropriation of \$200,000 into the fund to respond to the COVID-19 outbreak. Establishing the fund will allow the Borough to track expenses that may be reimbursed by the federal government. This Emergency Ordinance will be effective immediately upon adoption, which takes one reading only, and will continue in effect for sixty (60) days unless sooner repealed.

Ordinance #2020-10: An Ordinance Amending the FY 2019/2020 Budget to Establish a Local Emergency Disaster Fund to Respond to the COVID-19 Outbreak

Ordinance #2020-10 will amend the FY 2020 budget to establish a Local Emergency Disaster Fund to respond to the COVID-19 outbreak extending past the 60 day Emergency Ordinance.

Ordinance #2020-11: An Ordinance Approving the Borough's Participation in a Proposed Refinancing by the Alaska Municipal Bond Bank of its General Obligation Bonds, 2010 Series One (Issued in Two Series, One Tax-Exempt and One Taxable), which Provided Funds to Purchase the City of Petersburg General Obligation Electric Utility Bond, 2010 Series A (Tax-Exempt) (the "2010A Bond"), and the City of Petersburg General Obligation Electric Utility Bond, 2010 Series B (Taxable Build America Bond) (the "2010B Bond"), Under a Loan Agreement Between the City and the Bond Bank; Authorizing the Borough Manager and Finance Director to Enter into a New Loan Agreement with the Bond Bank Setting Forth a Revised Debt Service Schedule with Respect to the Loan Evidenced by the 2010A Bond and the 2010B Bond, In Accordance with the 2010 Loan Agreement, if the Bond Bank Successfully Refinances its 2010 Bonds; Authorizing the Issuance of a New Bond or Bonds to the Bond Bank to Evidence the Refinanced Loan; and Establishing an Effective Date

Petersburg's Elecric Utility General Obligation Bonds (2010-A-1 & B-1) are eligible to be refunded. The municipal bond bank is working with communities, including Petersburg, to facilitate a transaction due to the low market rates. There is a projected \$270,000 in savings to the Petersburg Electric Department over the next 10 years until maturity of the bonds.

Recommended motion: To approve the refunding of Petersburg's 2010 General Obligation Bonds, Series 2010-A-1 and 2010-B-1.
