The State of Alaska, Department of Natural Resources, requires borough mayors to sign for acceptance of any land dedicated for public use and for public purposes within the borough, regardless of whether or not the borough has platting authority in the area. This land dedication is in the area of 10 mile Mitkof Highway/Falls Creek, which is currently exempt from platting authority. Acceptance of lands for public use or public purpose does not obligate the public or any governing body to construct, operate or maintain improvements. DNR is requesting Mayor Jensen sign the plats of the TLS 2018-12 - P-1A and P-1B Subdivision.

D. Authorization for Mayor Jensen and Manager Giesbrecht to Attend a Shipping Cost Summit in Ketchikan on January 24, 2019

Regional Mayors and Managers recently met to discuss the high cost of barge transportation of goods and supplies. The Mayors decided to inquire if other affected communities statewide are interested in holding a Shipping Summit to discuss proposed actions municipalities and businesses can take to help counteract the problem of high shipping costs. The Summit is proposed for January 24, 2019 in Ketchikan. The estimated cost for Mayor Jensen and Manager Giesbrecht to attend the Summit is \$1.600.
