A. Ordinance #2016-11: An Ordinance Amending Borough Code by Providing for a New Chapter 4.70 to Impose Excise Taxes on the Cultivation, Manufacture and Retail Sale of Marijuana and Any Marijuana Product

Ordinance #2016-11 imposes excise taxes on marijuana and marijuana products sold in the Borough. This ordinance, as it is currently written, is still under legal review and may have revisions when it is brought forward for its second reading at the September 19, 2016 Assembly meeting. The purpose of introducing this ordinance prior to completion of legal review is to open the conversation on the subject of marijuana excise taxes.

The State of Alaska, Department of Natural Resources, requires borough mayors to sign for acceptance of any land dedicated for public use and for public purposes within the borough, regardless of whether or not the borough has platting authority in the area. This land dedication is in the area of 9 mile Mitkof Highway, which is currently exempt from platting authority. Acceptance of lands for public use or public purpose does not obligate the public or any governing body to construct, operate or maintain improvements. The plat has been reviewed by Electric Superintendent Nelson, Assistant Public Works Director Cotta and Community and Economic Development Director Cabrera. Nelson and Cotta are comfortable with the subdivision as it is drawn. Cabrera's comments are attached. Mayor Jensen will need Assembly authorization to sign the plat of the Ramstead Homestead Subdivision.
