## 15. New Business

A. Ordinance #2016-11: An Ordinance Amending Borough Code by Providing for a New Chapter 4.70 to Impose Excise Taxes on the Cultivation, Manufacture and Importation of Marijuana and Any Marijuana Product for Commercial Use

Manager Giesbrecht reported information the Borough received from its attorney regarding the changes that need to be made to the ordinance. Based on this information, the language regarding retail tax will be removed before the next reading of the ordinance.

Vice-Mayor Lagoudakis made a motion that the language regarding use of the excise tax proceeds be amended to state that up to 50% of the proceeds will be used for alcohol and drug health related purposes and that those purposes would be decided each year during the budget process. The amendment passed by a vote of 4-1, Assembly Member Strand opposing.

Ordinance #2016-11 passed its first reading, as amended, by a vote of 4-1, Assembly Member Strand again opposing.

Approval of the Borough's letter supporting the Alaska Mental Health Trust Land Exchange Act of 2016 was given with amendments adding a "Plan B" option of an endowment fund if the land exchange fails, adding backup documentation regarding past landslides in the area, and sending copies to Senator Dan Sullivan and the Ketchikan Gateway Borough.

After discussion between the Assembly, Manager Giesbrecht, and Community Development Director Cabrera regarding concerns with the property, largely due to the small size and the slope of some of the lots making it difficult to develop adequate wastewater drainage and lack of convenient driveway access to Mitkof Highway, the authorization failed unanimously.

Deputy Clerk Thompson was directed to send to the Alaska Department of Natural Resources a narrative explanation of the reasons for the refusal to sign the acceptance of the land for public use and public purpose.
