7. Visitors' Views Related to Agenda

Bob Lynn, representing himself, spoke in support of beginning dialog with DNR regarding Papke's Landing. He requested the Borough follow up on a letter sent from the Assembly to the State regarding parking enforcement in the Papke's Landing area. Mr. Lynn stressed that the Papke's float is the highest priority as it is rapidly failing. He also suggested use of a Borough-wide launch fee to launch boats at any Borough maintained launch ramp to pay for maintenance of the facilities.

Mr. Lynn spoke regarding his experience and knowledge of hydrology, selection of hydroelectric dam sites, dam failures, and engineering and design of transmission lines, including lines constructed and maintained by SEAPA.

Mike Bangs, representing himself, spoke to the Assembly about possibly changing the Charter to allow members of the Hospital Board, the Planning Commission and the School Board to also be a member of other boards, commissions or committees because it seems that Petersburg is often short on citizens willing to serve.
