PETERSBURG BOROUGH ORDINANCE #2016-05

AN ORDINANCE OF THE PETERSBURG BOROUGH ADOPTING THE BUDGET FOR THE FISCAL YEAR JULY 1, 2016 THROUGH JUNE 30, 2017

<u>Section 1.</u> Classification: This ordinance is not of a permanent nature and shall not be codified in the Petersburg Municipal Code.

<u>Section 2.</u> Purpose: The purpose of this ordinance is to set forth budgetary requirements for the operation of the various divisions, departments and organizations of the Petersburg Borough for Fiscal Year 2017. Support to the Petersburg School District has been included in the General Fund Expenditures.

<u>Section 3.</u> <u>Substantive Provisions:</u> In accordance with Section 11.07 of the Charter of the Petersburg Borough, the budget for the fiscal period beginning July 1, 2016 and ending June 30, 2017 is hereby approved in the amounts and for the purposes as stated below. The supporting line item budget detail, as reviewed by the Assembly, is incorporated as part of this ordinance.
