



**Borough Manager's Report
Assembly Meeting 1 August 2016**

- ❖ The 30% design documents for the Emergency Stand-by Generator (350 kw) replacement have been received from the vendor.
- ❖ At Crystal Lake, we intend to replace the old “bubbler” lake level indicator system with a new electronic transducer, and add a new air temperature sensor – weather permitting. When complete, we will no longer have to maintain the nitrogen gas system at the lake, and the readings will be much more reliable and accurate.
- ❖ Spillman Records Management System implementation was completed on 7/19/2016. Employees continue to learn the system. This will allow us over time to provide much better data on Police and Emergency Services issues.
- ❖ Governor Walker signed the Omnibus Crime Reform Bill on 7/11/16. Portions took effect on 7/12/16. The bill decriminalized many behaviors and adjusted classification of others. We're awaiting further information and guidance from the Department of Law.
- ❖ Waitlists for Elderly Housing and Assisted Living. We have 16 out of 20 apartments assisted living with . 4 remaining independent.
- ❖ Summer Camp is continuing to run as planned. Rhiannon Kivisto and Mara Lutomski have stepped forward from the community to help operate it. We are at full capacity for all weeks. Thank you to the Chamber of Commerce for allowing Mara to be with us for two weeks. She is amazing!
- ❖ There is a Wrestling Tournament in the Gymnasium/Basketball Court from August 2nd-8th. All normal programming is cancelled during the tournament.
- ❖ Chandra is teaching water fitness on Tuesday & Thursday mornings from 630-730am, and Saturday mornings from 7-8am. She invites everyone to come on out and join in on the fun!
- ❖ The Summer Reading Challenge is over. A VIP pool party was held this past Thursday for the kids who read 840 minutes or more this summer. Thanks to Parks & Rec for hosting it!
- ❖ Auditors are here from August 1 – 5, for the Borough's annual audit.
- ❖ Borough land auction to be pushed back to a later date (October?) waiting for Planning and Zoning to meet.
- ❖ Drive Down Bulkhead project is on schedule. Materials are arriving and work is ramping up to drive the sheet pile and fill.
- ❖ South Harbor parking is very tight; we appreciate the public assistance in leaving vehicles at home in between trips.

- ❖ Public Works staff completed all prep work needed prior to paving of local streets by SECON. Now we wait for the weather to cooperate. We will be following SECON's paving efforts with cleanup of side streets, and shoulder protection of the fresh asphalt.
- ❖ CBC Construction has mobilized to Petersburg and is most of the way through with upgrades to Pump Station 2. Once complete, they will move directly to Pump Station 1 for that upgrade work. Once both stations are ready, the contractor will initiate use of the new force main and decommission the old force main on the South Harbor beach.
- ❖ SEASWA is working with Waste Management for development of scrap metal removal contracts for the Authority's member communities. A WM representative will be visiting Petersburg in the first week of August to review our operation and learn about the logistics for scrap removal from the landfill.
- ❖ Surplus vehicle auction by sealed bids is ongoing. Auction items are advertised in the Petersburg Pilot. Bid opening to occur on August 4th.
