Brian Lynch, representing himself and Salmon Without Borders, shared information regarding the draft Statement of Cooperation for Transboundary Waters Governor Walker's office is working on with British Columbia Premier Christy Clark, and the Memorandum of Understanding and Cooperation that was signed by both parties on November 25, 2015. He urged the Assembly to send another strongly worded letter to Governor Walker requesting he ask Alaska's federal delegation to speak to US Secretary of State Kerry about an International Joint Commission reference on this issue, as well as to sign onto a letter to Governor Walker drafted by Salmon Beyond Borders along with many other Southeast Alaskans.

The Assembly unanimously agreed to have Mayor Jensen send a second letter on the Transboundary Waters issue to Governor Walker, as well as sign onto the letter drafted by Salmon Beyond Borders.
