Finance Director Tow is recommending that Transient Room Tax revenue and corresponding expenses be moved to a new special revenue fund. Currently the tax expenditures are found in the community services budget of the General Fund. Moving the Transient Room Tax out of the General Fund and into a Special Revenue Fund will create more transparency when making future budget decisions. This ordinance passed in its first reading at the May 4, 2015 Assembly Meeting and in its second reading at the May 18, 2015 Assembly Meeting.

Ordinance #2015-02: An Ordinance Providing for a Farm Property Tax Exemption and Submitting the Ordinance to the Voters (short title).

The ordinance provides for a property tax exemption for farm structures when a land owner meets specific requirements. The ordinance has been amended since its first reading for clarity by legal counsel, and if approved, by the Assembly, the ordinance will be submitted to the voters for ratification at the October 6, 2015 municipal election. At the February 2, 2015 meeting, the Borough Assembly voted to postpone the second reading of the ordinance until the first meeting in June to allow the Alaska Legislature to rule on Alaska's new marijuana law. To our knowledge, this ruling has not taken place.

The Middle Harbor Repair Project received two qualified bids, one of which is from Tamico, a local company. Tamico's bid qualified for the local bidder preference. The bids on the project are within the 5% local bidder qualification. The Borough's Ordinance 4.04.050 states that the award of a local bidder preference is at the discretion of the Borough Assembly. Upon the Assembly's decision at the June 1, 2015 meeting, staff will issue the Intent to Award letter to the two responsible and qualified bidders and then ask the Assembly to formally award the contract at the June 15, 2015 Assembly meeting.
