It is time to do your "annual" filing with APOC . However, APOC is telling me they do not have a record of some of you ever filing your " initial" filing. But, we all know that you did or Election Divisions would not have placed your names on the incorporation ballot. Anyway, APOC says they will work with us to get all our filings in without too much hassle on our end, and hopefully not fining anyone for being "late".

Even though you may file a paper POFD please consider **filing electronically**. Electronic filing is much faster and easier for future use. Regardless of which way you choose to file (electronic or paper), **please assure you**

**provide me with: a copy of your electronic filing or the original of your paper filing.** State Statute requires local officials to file POFDs with their local clerks. If you chose to file by paper, you may bring the original to me for our records and I will copy it and forward to APOC.

## **File by March 15**

Following are instructions for each of you:

### **Assembly:**

**Nancy Strand:** you need to amend the filing that you and I worked on last week to call it your "initial" filing. We called it your "annual" filing. You will not have an "annual" filing due until 2015.

**Mark Jensen, Bob Lynn and John Havrilek:** all of you must file an "initial" POFD. You will not make an annual filing until 2015, or until you re-run or leave office.

**John Hoag:** you need to file an "initial" POFD. However, APOC does have a record of you filing an electronic "candidate" POFD. You might be able to use the data entered for the candidate filing toward your initial filing. You will not file an annual POFD until 2015.

**Kurt Wohlhueter & Cindi Lagoudakis:** you must file your "annual" POFD.

### **School Board:**

**Jean Ellis:** you need to file an "initial" POFD. However, APOC does have a record of you filing an electronic "candidate" POFD. You might be able to use the data entered for the candidate filing toward your initial filing.

**Sarah Holmgrain, Cheryl File, John Bringham, Dawn Ware,** you must file your "annual" POFD.

### **Planning Commission**

**Dave Kesinger, Susan Thomason, Dona Malhoit Laubhan, Otis Marsh:** you must file your "annual" POFD.

**Louis Fry, James Demko and Ronn Buschmann:** all of you must file an "initial" POFD.
