Ordinances for Third and Final Reading

A. Ordinance #2016-06: An Ordinance Adding Marijuana Regulations to Chapter 6.04, Alcoholic Beverages & Marijuana

Ordinance #2016-06, which adds marijuana regulations to Chapter 6.04 of the Municipal Code, passed in its second reading on June 6, 2016. To be consistent with the Assembly's removal of all language allowing for marijuana use at marijuana retail establishments from Ordinance #2016-08 (the Smoke Free Air Act) during its second reading, Clerk Thompson removed Section 6.04.065 (Onsite use of marijuana at a retail location) from this ordinance.

B. Ordinance #2016-07: An Ordinance Adding Fines for Marijuana Violations to Chapter 1.16, General Penalty and Interest

Ordinance #2016-08 was amended in its second reading to add the words "aerosol and vapor" in regards to electronic cigarettes and to remove all wording allowing for the smoking of marijuana at a properly licensed marijuana retail establishment.

Ordinance #2016-09 uses DNR Grant funds on the Hungry Point Trail Extension project, provides for the use of National Forest Receipts Streets and Roads Fund monies to perform additional paving on specific local streets, and adds a Homeland Security grant unintentionally left off the FY 2017 budget to be used for the purchase of Public Safety Communications Equipment previously approved by the Assembly.

A. Presentation to Assembly of Certified Citizen's Initiative Petition to Submit to Borough Voters the Question of Prohibiting Marijuana Establishments in the Petersburg Borough

A citizen's initiative petition to submit to the qualified voters of the Petersburg Borough the question of prohibiting marijuana establishments in the Borough on a Municipal Election ballot was filed on June 27, 2016 and certified by Clerk Thompson as in good form and sufficient on July 9, 2016. The petition contains 434 valid Borough voter signatures (the amount of Borough voter signatures needed for sufficiency was 104), . The petition was filed and certified less than 180 days before the date of the next Regular Election on October 4, 2016, thereby requiring a Special Election be held within 90 days of certification (90 days from July 9 is October 7, 2016).

The Assembly has the opportunity to adopt an ordinance under Section 2.44.080 to place the question proposed by the initiative petition on the regular Municipal Election ballot, thereby avoiding the need for and cost of a Special Election if desired.

Ordinance #2016-10: An Ordinance Submitting to the Qualified Voters of the Petersburg Borough the Question of Prohibiting the Sale and Importation for Sale of Marijuana and Any Marijuana Product and the Operation of Any Marijuana Establishment, Including All of the Following License Types: Retail Marijuana Store, Marijuana Cultivation Facility, Marijuana Product Manufacturing Facility and Marijuana Testing Facility, Within the Petersburg Borough, on the October 4, 2016 Municipal Election Ballot

If adopted, Ordinance #2016-10 would submit the question to prohibit marijuana establishments in the Petersburg Borough proposed by the citizen's initiative petition that was certified as sufficient by Clerk Thompson on July 9, 2016 onto the regular Municipal Election ballot to be held on October 4, 2016. Adoption of this ordinance would render a Special Election on the subject unnecessary.
