## PETERSBURG BOROUGH ORDINANCE #2016-12

## AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP FOR SERVICE AREA 1 OF THE PETERSBURG BOROUGH, TO REZONE PARCEL #01-014-125 AT 919 SANDY BEACH ROAD FROM PUBLIC USE (P-1) TO SINGLE-FAMILY RESIDENTIAL (S-F)

WHEREAS, Chapter 19.84 of the Petersburg Municipal Code (Service Area 1) provides for zoning amendments whenever the public necessity, convenience or general welfare requires; and

WHEREAS, the Petersburg Borough, owner of Parcel #01-014-125 submitted a request to rezone the below described property from Public Use (P-1) to Single-Family Residential (S-F); and

WHEREAS, the Planning Commission conducted a public hearing on the rezone request on August 23, 2016, after the notice required by the Municipal Code was provided; and

WHEREAS, at the October 25, 2016 Planning Commission meeting a motion to recommend to rezone failed due to a lack of a second and no findings were reported to the Assembly; and

WHEREAS, the Borough Assembly originally approved the sale of Parcel #01-014-125 by Resolution #2016-14 with the plan to complete the rezone process prior to the sale in order to be consistent with the intended use of the land and existing use of surrounding properties; and

**WHEREAS**, Section 1.12.010(G) of the Municipal Code requires amendments to the official zoning map be enacted by ordinance.

## THEREFORE, THE PETERSBURG BOROUGH ORDAINS as follows:

<u>Section 1. Classification</u>. This Ordinance is of a general and permanent nature, but will not be codified in the Municipal Code.

<u>Section 2. Purpose</u>. The purpose of this Ordinance is to amend the Official Zoning Map for Service Area 1 of the Petersburg Borough.

<u>Section 3. Substantive Provisions</u>. The Official Zoning Map for Service Area 1 of the Petersburg Borough, codified and referenced in Section 19.08.020 in the Municipal Code, is hereby amended for the following described property from Public Use (P-1) to Single-Family Residential (S-F):

Lot 10, Section 35, Township 58S, Range 79E located at 919 Sandy Beach Road, Petersburg, Alaska, containing approximately 1.33 acres (Parcel #01-014-125)

<u>Section 4. Where Record to be Maintained.</u> This non-Code ordinance, and the requirements herein, shall be maintained with the zoning records of the Borough.

Section 5. Effective Date. This Ordinance will take effect immediately upon adoption.
