Re: SEAPA Rebates

Dear Member Communities:

During the September 3, 2014 meeting of the Southeast Alaska Power Agency (SEAPA) Board of Directors, SEAPA management provided an overview on how funds flow within the Agency, why reserve funds are maintained, how they are managed going forward, and how they flow into the development of Agency projects. Each member community/utility director was given an opportunity to offer comments and ask questions following management's discussion. After a review of how funds flow within the Agency, your SEAPA board approved a Fiscal Year 2015 (FY15) rebate to its member communities/utilities in the equivalency of ½ cent per kWh based on the last three-years' average of the member utilities' firm kWh purchases from SEAPA. It was noted that rebates are subject to audit compliance, bond requirements, and no unforeseen events occuring that will encumber the funds otherwise.
