The State of Alaska, Department of Natural Resources, requires Borough Mayors to sign for acceptance of any land dedicated for public use and for public purposes within the Borough, regardless of whether or not the Borough has platting authority in the area. This land dedication is in the Point Agassiz area, which is currently exempt from local platting authority. Acceptance of lands for public use or public purpose does not obligate the public or any governing body to construct, operate or maintain improvements. The Mayor will need Assembly authorization to sign the plat of the Ramstead Homestead Subdivision.

The State of Alaska has offered to transfer ownership of the Papke's Landing Float, the Kupreanof Float, and the Entrance Island Float to the Petersburg Borough along with a lump sum payment of \$732,883 toward deferred maintenance. Condition assessments were performed on the Papke's Landing and Kupreanof Floats during the development of Petersburg's Comprehensive Plan and Waterfront Master Plan that determined the cost to bring the floats to a safe and usable condition would be \$1,050,000 for Papke's Landing and \$1,395,000 for Kupreanof. The Borough Assembly is seeking input from the community regarding acceptance or denial of the State's offer.
