Mayor Jensen read his written report which informed of: receipt of a letter of interest from Sue Erickson to continue her seat on the Transient Room Tax Committee; receipt of a letter of interest from Gloria Ohmer who would also like to continue as a member of the Transient Room Tax Committee; notice of voting precinct boundary changes due to the Alaska Redistricting Board's adoption of new boundaries for the Alaska legislative house and senate districts; reminder to the Assembly that mandatory Public Official Financial Disclosure paperwork is due to the Alaska Public Offices Commission by March 15; the Mayor and Manager will be traveling to Juneau next week to meet with our legislators and lobby for Borough projects; the Mayor has been invited to testify to the Fisheries Committee on the effect of sea otters on southeast fisheries and will do so representing himself, not the Borough; and, Board of Equalization training will be conducted immediately before the March 17 regular Assembly meeting, and the Assessor is requesting to have the Board of Equalization hearings on Wednesday, April 2, 2014.

Without objection, Susan Erickson and Gloria Ohmer were appointed as members of the Transient Room Tax Committee. Board of Equalization training will be conducted beginning at 6:00 p.m. on Monday, March 17, 2014, and Board of Equalization hearings will begin at 9:00 a.m. on Wednesday, April 2, 2014.

Ordinances for Third and Final Reading

Α.

Ordinance #2014-01: An Ordinance Providing for Chapter 3.50 (Hospital Board) of the Municipal Code, Updating Current Language to Reflect Borough Incorporation; and Providing Provisions for the Hospital Board for the Borough. Third and Final Reading.

The ordinance was amended after its first reading to repeat the Charter requirement that the Hospital Board prepare, adopt and submit to the Borough a six-year capital project improvements plan for equipment and buildings along with its annual budget.

B.Ordinance #2014-04: An Ordinance Providing for Title 2 (Elections) of
the Municipal Code, and Updating Current Language to Reflect
Borough Incorporation. Third and Final Reading.

The ordinance retains all processes and functions for in-person voting that our residents are accustomed to.

Ordinance #2014-04 was approved by unanimous roll call vote in its second reading.

C. Ordinance #2014-05: An Ordinance Providing for Title 10 (Criminal Code) of the Municipal Code and Updating Current Language to

Reflect Borough Incorporation. Third and Final Reading.

This ordinance has been revised to remove outdated and unused portions of the previous code. Also, portions of the code have been updated to allow the police department to process minor crimes as Borough ordinance violations. Under this revision, officers would have the discretion to issue a Borough citation, in lieu of arrest, for common offenses. Allowing for the disposition of cases in this manner will provide defendants with a speedier process and will reduce the amount of police, prosecutor, and court resources needed to process what were traditionally criminal cases. Nothing in this revision prevents officers from making physical arrests and processing criminal violations in the current manner.

Other revisions include the adoption of current state watercraft statutes similar to the Borough's previous adoption of traffic administrative codes and statutes.
