PETERSBURG BOROUGH ORDINANCE #2020-13

AN EMERGENCY ORDINANCE AMENDING THE FY 19/20 BUDGET TO APPROVE AN EMERGENCY APPROPRIATION OF \$100,000 FROM THE ECONOMIC DEVELOPMENT FUND TO THE PETERSBURG ECONOMIC DEVELOPMENT COUNCIL INC TO MITIGATE LOCAL ECONOMIC IMPACTS RELATED TO THE COVID-19 OUTBREAK

- WHEREAS, on March 11, 2020, the World Health Organization declared the COVID-19 virus a pandemic; and
- WHEREAS, numerous cases of COVID-19 within the State of Alaska have been identified, and the Borough Assembly declared a Declaration of Local Disaster Emergency in Petersburg on March 16, 2020; and
- WHEREAS, on March 27, 2020, Governor Michael Dunleavy imposed a state health mandate (#011) requiring every Alaskan to remain at their place of residence and practice social distancing unless engaged in an essential business activity, and ordering the closure of non-essential businesses; and
- **WHEREAS**, while these measures are critical in mitigating the rate of spread of the COVID-19 virus, they are having significant negative economic effects on small businesses and workers; and
- WHEREAS, disruptions to workers and small businesses are detrimental to both individuals and to the Borough, as small businesses are the backbone of Petersburg's economy, and provide the foundation of employment, services for the community, and revenue for the municipality to continue to provide essential services for the public welfare and benefit; and
- **WHEREAS**, small business plays a vital role in the overall health and welfare of Petersburg's citizens and resources are necessary to help small businesses survive and certain small businesses reasonably require financial assistance to survive; and
- WHEREAS, the Petersburg Economic Development Council, Inc. (PEDC) is tasked with leading economic development activities within the Petersburg Borough and informed the Borough Assembly that response to the Covid-19 pandemic is having significant impact on the business community, including the state-mandated closures; and
- WHEREAS, the need to respond to the economic impact was unanticipated and not included in the budget adopted by the Borough in June of 2019, and thus requires a budget amendment and an emergency appropriation; and
- **WHEREAS**, providing immediate resources for the PEDC for services during this declaration of emergency, and enabling the PEDC to respond quickly to the business community's needs is critical; and
- WHEREAS, the Assembly determines that the appropriation of funds provided for herein will serve a public purpose and the general welfare of the community of Petersburg by relieving

economic distress caused by the COVID-19 health crisis; and

WHEREAS, Borough Charter Section 3.03 provides for Emergency Ordinances that in the judgment of the Assembly are necessary for the immediate preservation of the public peace, health or safety; and

WHEREAS, an emergency exists as it is vital that the Borough and PEDC be able to respond rapidly and efficiently to the evolving economic situation which exists and there is insufficient time to follow ordinary ordinance adoption procedures in the existing time frame.

THEREFORE BE IT ORDAINED, by the Petersburg Borough Assembly, that the Borough FY 2019-2020 budget is hereby amended to transfer \$100,000 from the Economic Fund to the Petersburg Economic Development Council, Inc. to use to mitigate economic impacts on Petersburg-based businesses, particularly those businesses deemed non-essential and closed to the public by state or borough mandate.

BE IT FURTHER ORDAINED, that the funds appropriated shall be distributed by PEDC in accordance with the eligibility and priority criteria set out in Attachment A.

<u>Classification:</u> This Emergency Ordinance is of a non-permanent nature and shall not be codified in the Petersburg Borough Code.

Effective Date: This Ordinance shall be effective immediately upon adoption.
