David Beebe, representing himself, spoke in opposition to the Kake Access Road project.

Kurt Kivisto, Alaska Marine Lines/Alaska Marine Trucking Terminal Manager, shared Lynden, Inc.'s intention to continue their shipping services while taking steps to protect their employees and customers and mitigate the spread of COVID-19.

Barry Morrison, Trading Union General Manager, and Jim Floyd, Hammer & Wikan General Manager, shared their plans for service to the community during the pandemic. Both stores are receiving grocery orders via email, their employees will perform the shopping and the groceries can either be delivered to the customer or picked up. They encourage locals not to binge or panic shop - supplies will be restocked as soon as possible. Mayor Jensen reminded the public that Fire/EMS Director Dixson is the Local Emergency Planning Committee (LEPC) contact for the Borough. He stated his hope that the LEPC is looking into how to monitor small cruise ship traffic to Petersburg during the pandemic.

Assembly Member Tremblay stated the situation is changing rapidly and reminded everyone to stay out of groups.
