Motion was made to accept ownership of the Entrance Island, Kupreanof and Papke's Landing docks.

The main motion was amended to not accept ownership of the Entrance Island dock, to request ADOT&PF give the Kupreanof dock directly to the City of Kupreanof, or for the Borough to accept the Kupreanof dock and convey the dock to the City of Kupreanof once changes to the Borough Charter that will allow Kupreanof to own and operate their dock facility within the Borough are approved by the voters, to request ADOT research and provide a Corp of Engineer's permit for the Kupreanof dock, and that they work with DNR to transfer ownership of the tidelands associated with the Kupreanof facility along with the dock. The amendment passed unanimously.

The main motion was further amended to request ADOT&PF work with DNR to transfer the Corp of Engineer's permit and ownership of the tidelands associated with the Papke's Landing facility to the Borough along with the dock. In addition, the Borough will request \$1,200,000 in harbor deferred maintenance funds. The second amendment passed unanimously.

The main motion, as amended, was unanimously approved. A letter outlining the Assembly's decisions and requests will be sent to ADOT&PF from Mayor Jensen.
