A. ORD#13-01 An Ordinance Providing for Chapter 4.36 of the Municipal Code and
 4 Updating Current Language to Reflect Borough Incorporation

The ordinance carries over the City of Petersburg Code provisions to the Borough Code. There are no substantial changes from present Code.

B. ORD#13-01 An Ordinance Providing for Title 6 of the Municipal Code and Updating
 Current Language to Reflect Borough Incorporation

The ordinance carries over the City of Petersburg Code provisions to the Borough Code; changes the hours of sale of alcoholic beverages (Sec. 6.04.050) and places more restrictions and license application process for itinerant merchants (door to door sales, solicitors, etc). The limitations placed on itinerant merchants do not apply to local fund raising activities or garage/yard sales held by individuals selling their personal belongings.

The resolution demonstrates Petersburg's support for SEAPA to take over operation and maintenance costs of the Tyee Lake Hydro Project under the same terms (or similar negotiated terms) contained in SEAPA's CEO's August 19 memo to the TBPA President. The resolution expresses Petersburg will no longer fund future non-net billable items as in the current budget and that if Wrangell does not accept the terms, or similar negotiated terms, as offered by SEAPA, the Wrangell community will be solely responsible for the unfunded PERS liability. The current liability is estimated to exceed \$750,000.

D. 13-224 Receipt of Non-Compliance Report on Dangerous Buildings and Scheduling of Noncompliance Hearings

The Borough has notified the owners of two properties within Service Area 1 that their properties contain dangerous buildings that must either be improved to meet code provisions or be demolished. Both owners have failed to comply with written notices. Community Development Director Luczak is requesting the Assembly schedule a Non Compliance Hearing. To observe noticing requirements, the hearing should be scheduled mid to late November.

E. 13-235 Authorization to Move Drive-Down Commercial Dock Facility to Final Design and Bid Phases

The Harbor Board, at their September 13th meeting, reviewed and approved the 95% design plans. They have recommended the Assembly direct PND Engineers to prepare the final construction documents and move the project to bid. Base bid for the project is estimated at 10.851 million. PND has provided 7 bid alternates. The Borough received 10.8 million dollars in grant funds from the state
