## Effective Date of This Amendment - September 15, 2017

WHEREAS, the Original Lease dated September 15, 1992, as amended, provides for renewal of the term of the lease and the annual rental rate to be adjusted on each fifth anniversary of the date of the lease and the renewal rate shall be based on the appraised fair market value of the premises and any borough improvements, and

WHEREAS, Borough Code lease provisions have been changed to alleviate the requirement for the lessee to obtain a property appraisal report every five years for annual rent rate determination and renewal, and

WHEREAS, Borough Code now requires the annual rent be adjusted by the borough on each fifth anniversary of the date of a lease and the new annual rent shall be based upon the current full and true value of the property and any borough owned improvements, as established by the borough's assessor, and

WHEREAS, Lessee and Lessor wish to amend the lease to provide rental rate renewal per current Borough Code.

THEREFORE BE IT RESOLVED, the original lease dated September 15, 1992, as amended, is further amended as follows:

Pursuant to Section 3.5 of the Original Lease, as amended, the annual rental rate for the five year period from September 15, 2017 through September 14, 2022 is:
