**2. Southeast Transportation Plan** - ADOT will be conducting a public meeting on the Plan Wednesday, August 13 here in the Assembly Chambers. The public meeting will consist of an Open House from 5:30 – 6:30 p.m. with the public meeting from 6:30 – 8:30 p.m. Residents are encouraged to attend the meeting to better understand this 20 year plan.

Borough staff has delayed preparing a draft comment letter to the Plan for Assembly consideration until after the August 13 public meeting. ADOT is accepting public comment to the Draft Plan until September 30, 2014.

### **WHAT:**

The Department of Transportation and Public Facilities (ADOT&PF) is updating the Southeast Alaska Transportation Plan (SATP). It guides the next 20 years of investment in Southeast Alaska's regional transportation network (State ferry acquisition and terminals, airport development, and State Highways).

(Note: The Petersburg-Kake Road is a recommended regional improvement in the draft SATP. It is one of several projects included that are also part of other Environmental Impact Statements (EIS), for which separate reviews and comment periods will be announced. Comments intended to be part of the administrative record for an EIS must be submitted to that EIS project manager during the specified comment period for each.)



TLO financing is available for successful bidders with a total down payment of 10% of the sale price. You do not need to be an Alaskan resident to bid on Trust land.
