\$46,536.00, we are seeking funds for personnel and operational cost.

Have you received funding in the past? If so how were the funds used?

Working Against Violence for Everyone, WAVE, has not received funds from the borough in the past.

In the past, WAVE was provided with office space before the Romiad building was torn down. (March 2012)

How will the requested funds fit into your organization's strategic plan for operations? Please include who and how many community members would be served and the consequences of not receiving funding.

WAVE is currently heading into a funding gap. Our funds from the state of Alaska will be ending June 30, 2016. The next victims service RFP with the State of Alaska will be open for FY18. We have applied for a very competitive federal grant but we will not know if we received funds till September 30. We are hopeful but not expecting to receive these funds. In 2015, 37 programs were funded from this federal grant.

We have worked with The Foraker Group to develop a strategic plan which includes preparing for our current funding situation by searching for multiple funding source including increasing our fundraising efforts, seeking larger donations, and applying for federal, state, and local funds as available. We have also worked with other organizations to research grant opportunities and will continue to seek funds from other sources.

According to the Alaska Victimization Survey 59% of women reported having experienced intimate partner violence. When compared with the national rate of 35.6% of women reporting similar episodes, it is clear that Alaskans are in need of advocacy, education and support for law enforcement response to sexual assault and domestic violence.

WAVE is the only program offering advocacy for sexual assault and domestic violence in the Petersburg area.

Working Against Violence for Everyone, serves any victim of domestic Violence and Sexual Assault in the Petersburg Borough.

WAVE has served the following victims:

A majority of our clients are people walking in to our office not calls to the crisis line. It is very hard for victims to reach out, it makes it only that much harder to reach out to a number, not knowing who is on the other end.

Assembly Members:

Working Against Violence for Everyone, WAVE, is a powerful but quiet organization here in Petersburg that helps many people and works with several community organizations. Every year there is an increase in the number of clients seeking help and information. Since we have had the opportunity for a full time employee and a permanent visible office space, we have seen our numbers increase even more.

In 2013 when we did not have full-time staff, we serviced 5 victims. In 2014, we helped 18 victims. In 2015, 21, and since January we are at 11. These numbers are only victims seeking services. This does not include those who contacted WAVE seeking information only. WAVE maintains a 24-hour crisis line, and victims can chat with an advocate online, but most of our connections happen from people walking into the office for services, and who are often referred from Petersburg Police Department, Petersburg Medical Center, Petersburg Trial Courts, or Petersburg Mental Health Services.

In addition to victim services, WAVE also helps with protective orders, connecting with lawyers for child custody and divorce cases, emergency housing, victim support, connecting with local counseling services, food, emergency transportation, safety planning, and danger assessments. Other services WAVE provides are, consent and personal safety talks at the schools, office hours at the high school, the Petersburg Moms Support Group, and domestic violence and sexual assault training for EMS and the ministerial association.

In 2013, WAVE received a 2-year grant from the State of Alaska, beginning FY'14. WAVE was awarded an extra year of funding for FY'16. Unfortunately, the next Victim Services Request for Proposal from the state does not come out until FY'18. This leaves us with a 1-year funding gap. WAVE has worked hard to find other funding sources for operating costs. Unfortunately, there are not a lot of funding opportunities to cover operating costs for non-profits. We have worked with other agencies to find funding sources and have been unsuccessful. The loss of funding for even one year will create a huge hardship on our available services to victims.

For all that we do, WAVE needs help. Due to the aforementioned funding gap for FY'17, we are requesting that the Borough help fund WAVE's operating costs in the amount of \$46,536. This amount would cover salary of one employee, rent, utilities, and the crisis line for one year. Our normal operating

budget is \$62,005. We plan to continue fundraising efforts for the additional amount to cover other costs, such as professional services, office supplies, and training. WAVE is such an important part of our community, and we would greatly appreciate your funding consideration to help us through this next
