The Petersburg Indian Association (PIA) approached the Borough requesting to purchase Borough-owned property located at 705 Ira II Street to build and manage a low-income duplex to address overcrowding in Petersburg homes. The Borough had previously offered the property for sale by public auction but had no bidders. Tlingit Haida Regional Housing Authority (THRHA) will purchase the property, build the duplex, and transfer ownership of the duplex to PIA upon completion. The grant funding associated with the project must be spent by the end of 2020 so construction of the duplex must commence as soon as possible. A resolution was drafted for the Assembly to consider a direct sale to THRHA - see Resolution #2020-14(A). The Assembly may approve a direct sale if it is determined that an exemption from public sale is in the best interests of the Borough per Municipal Code Section 16.12.060.

On August 4th Clerk Thompson was contacted by adjacent property owner Kathy Holtzinger, who stated interest in purchasing the property at 705 Ira II Street and requested the parcel be sold by public sale so she will have the chance to participate. Resolution #2020-14(B) was drafted to authorize a public sale of the property by sealed competitive bid. (Current restrictions on in-person attendance at public meetings due to the COVID-19 pandemic would make a public sale by outcry auction difficult.)

The Assembly is requested to decide whether the property sale shall proceed as a direct sale or as a public sale by sealed competitive bid.
