John Murgas, representing himself, spoke to Agenda Item 15G Economic Development Priorities for Manager Giesbrecht, noting the strategy to "recognize and support the three elements that collectively support the commercial fishing industry: harvesters, processors, and community" is missing the local service providers. Mr. Murgas requests the Assembly amend this strategy and proposed activities to include local service providers.

Ambre Burrell, representing Rock-N-Road Construction, spoke in favor of building the Kake Access Road.

Sonny Rice, representing herself, spoke to Agenda Items 11A Sanitation Rate Study Update, and 17A Sanitation Rate Study stating she is involved with a local group working on plastics issues and recycling in our community. Ms. Rice stated the local group would like to participate in the Borough's plans for the future regarding recycling. Ms. Rice also asked to speak on Agenda Item 15E Resolution #2020-02 which if approved will authorize and direct the Borough Assessor to value low-income housing tax credit property based upon actual income derived from the property. She requested the Assembly inquire of Swell, LLC whether they are receiving tax breaks for building the affordable housing complex only, or will they also receive tax breaks for maintenance of the complex?
