## Initiative Petition Application and Resolution Supporting the Continuation of the Curbside Blue Bag Commingled Recycle Program

An initiative petition was filed to continue the blue bag recycling program by Angela Davis on April 8, 2015. The petition was certified as sufficient by Clerk Thompson on April 15, 2015. Ms. Davis and her sponsors have begun the process of collecting the required 255 signatures by July 14, 2015 to put the initiative on the next election ballot.

Borough Ordinance and State Statute mandate the initiative petition be presented to the Assembly at the next meeting following certification by the Clerk. The Assembly has the option to begin the process for adoption of an ordinance enacting substantially the same measure as the one contained in the initiative petition, or the Assembly can choose not to pursue adoption of such an ordinance. If the Assembly ultimately does not enact an ordinance adopting substantially the same measure as is contained in the initiative petition, the initiative petition will be placed on the ballot in a special or regular election, providing the petition sponsors submit the necessary qualified voter signatures before the deadline. If the Assembly adopts an ordinance enacting substantially the same measure as is contained in the initiative petition, then the initiative petition will not go before the voters.

Resolution #2015-09 has been drafted by the Borough and is substantially similar to the initiative petition resolution. It provides for voluntary curbside commingled recycling and offers a recycling receptacle choice to the customer - blue bags or recycle carts. Customers choosing to use blue bags for their recycles will purchase their own bags beginning October 1, 2015 (as mandated by the initiative petition) and will receive recycle pick up services from a contractor hired by the Borough. Customers choosing to use carts for their recycles will receive recycle pick up services from the Borough Sanitation department. The Borough and the blue bag recycle contractor will work together to ensure the stability and growth of commingled recycling in the Petersburg Borough.

If Resolution #2015-09 is approved by the Assembly, the Sanitation ordinance will be re-written and will have three readings before the Assembly before being enacted as law. The first reading of the ordinance would be May 4, 2015.
