### 1. Call To Order/Roll Call

Mayor Jensen called the meeting to order at 7:00 p.m.

## 6. Visitors' Views Related to Agenda

*Angela Davis of Ruger's Trucking read a recent "Letter to the Editor" in the newspaper. It addressed the need to curb our spending as a Borough. Ms. Davis stated that she believes the proposed resolution, which gives recycling customers a choice of blue bags or containers, is irresponsible. She questioned how the contractor would be paid if the truck and containers are purchased since no contractor was budgeted for in the next fiscal year. Ms. Davis expressed her desire to let the community decide what recycling program to use, which was the purpose of her resolution. She stated that she believes the customers who would like to continue using the blue bag system will now be forced to either convert to the containers or quit recycling altogether to avoid paying a higher sanitation rate. She encouraged the Assembly to deny the proposed resolution and give the community the choice. Ms. Davis stated that she had recently called other communities in Southeast Alaska and compared their 96 gallon can rates to Petersburg and that Petersburg had the highest rate. She also informed the Assembly that she and her husband were currently working on a proposal to purchase the sanitation department from the Borough. She concluded by asking the Assembly not to approve the resolution.*

*Catherine Kowalski agreed with Angela Davis' comments regarding the recycling matter. She expressed her desire that the public be given the opportunity to be a part of committees to work out issues. She stated that as a private business owner and a member of the Chamber of Commerce, she would be remiss in not supporting Ruger's Trucking. She urged the Assembly to let Angela Davis' original initiative continue on in the process.*

*Bob Martin stated his belief that a competitive bid private contract was the way to go for the recycling program. He expressed his concerns about apparent excess staff at the landfill, the purchase of a new sanitation truck, and the problem with blue bags in the recycling stream. Mr. Martin explained that he believes once the truck has been purchased, it will mean that there will not be a chance for a private contractor to be successful and would mean that the recycling program would eventually be completely Borough run. He complained about the fact that Borough staff could not help with the drafting of Angela Davis' resolution, but that a "competing" resolution was now presented which had been drafted by the Borough. Mr. Martin concluded by stating his belief that a lot of these issues could have been solved if there were a utilities board, which he would be willing to be a part of.*

*Charles Davis expressed his opinion that the expenses associated with a new sanitation truck did not make sense. He explained his concerns about the future of the commercial cardboard pick-up portion of the recycling program and the problems associated with the baler closure for three hours each day. He reminded the Assembly that the potential exists that if the contract portion of the recycling program is not sufficient enough to support Ruger's Trucking performing the duties, the Davises may decide to leave town, which means an effect on the schools and other businesses in Petersburg.*

*Patty Randrup expressed her concerns that the spending by the Borough is going to drive people out of town because it is too expensive for families to make it. She said that she believes we need more businesses in town.*

*Karen Malcolm stated her desire to go to a container-based recycling program to avoid the sanitation rates going up 9%. She reminded the Assembly that it would not only affect recycling customers but would be an across the board increase, and she was concerned about people on a fixed income.*

*Member Gregor expressed his desire to go to a container-only recycling program. He said, however, in light of the initiative, he believes the proposed resolution is the best way to keep recycling alive in Petersburg.*

*Public Works Director Karl Hagerman explained that the way to keep sanitation rates as low as possible is to implement a containers-only system and eliminate the blue bag system completely.*

*Member Wohlhueter asked how many sanitation workers with families would potentially lose their jobs if cuts were made to staff, to which Director Hagerman replied that there were four employees at the landfill.*

*Member Lynn stated that he did not believe it made sense to spend the money to maintain two separate types of recycling methods.*

*Member Strand expressed her understanding that the truck and container system is the way to save money. Director Hagerman reminded the Assembly that all the information he had supplied previously and posted on the Borough's website supported that fact.*

*Member Lagoudakis informed the Assembly that she had many people tell her they were not comfortable getting into the public debate on the recycling issue but that they were in favor of the containers. She also questioned Director Hagerman about how long he had expected the Ruger's Trucking contract to be, how long he anticipated the new sanitation truck to last, and what would become of the blue bags in the new proposed resolution. Director Hagerman replied that the contract was for 15 months, the truck should last 10 years, and the blue bags will be sent to the landfill in Washington.*

*Mayor Jensen stated his disappointment that the Borough wouldn't be saving money by going to a container-only recycling system. He informed everyone that the only way at this point for the sanitation rates to increase by only the 2% amount was for the sponsors of the initiative to pull it. He corrected the statements made earlier during visitors' views about the price and length of service of the new truck.*

*Member Wohlhueter suggested maybe the way to save money was to do away with garbage pick-up altogether.*

*After the Assembly vote, the decision was made that the Borough's attorney was no longer needed, and the call was discontinued.*

**By roll call vote, Resolution #2015-09 was approved 5-1, Member Lynn opposing.**
