Motion was made to draft a federal project and priorities list. Suggestions were: SRS, PILT, Section 107 Army Corps of Engineers (dredging), US Coast Guard, Transboundary Waters, President Trump's Infrastructure Program, which could include the Scow Bay Project or the Airport Bypass Road, and Essential Air Service. The Assembly decided to wait to finalize the list until after speaking with the Borough's Federal lobbyist, Brad Gilman, at the January 2, 2018 meeting.

The Assembly decided to ask for input from regional fishermen, local sea otter harvesters, and regional native groups regarding the Marine Mammal Protection Act as it relates to sea otters.

### 17. Assembly Discussion Items

### A. Recognitions

Assembly Member Castro reminded the community about Life Med Alaska's First Responder Contest and encouraged the public to vote for their favorite local First Responder.

Mayor Jensen recognized Representative Kreiss-Tomkins for holding the recent opioid forum in Petersburg.

B. Skype Option With Federal and State Elected Officials and Lobbyists

Assembly Member Meucci wondered if the Assembly can use Skype to keep in touch with the Borough's State and Federal delegations, their staff, and/or lobbyists, maybe on a quarterly basis. After some discussion, some members of the Assembly thought they should try Skyping with Borough lobbyists first.

C. History of Senior Sales Tax Exemption

Assembly Member Meucci discussed his research, with the help of Borough staff, on the Senior Citizens Sales Tax Exemption and how it was created (by ordinance, not by a vote of the people). He shared that currently the Borough has 550 active exemption cards. Assembly Member Wohlhueter shared that the original ordinance that created the exemption specifically states that if you were age 65, this ordinance was "to alleviate financial hardship". He feels the Assembly should define what alleviating financial hardship means. Assembly Member Marohl requested Jody provide an estimate, including untaxed utilities, of the sales tax the Borough is currently missing out on.

D. Administrative Fee for Senior Sales Tax Exemption Participants

Assembly Member Meucci discussed the reasons for wanting to restructure the Senior Citizen Sales Tax Exemption, and stated that an administrative fee might dissuade some seniors that don't really have a financial need for the exemption from applying. He hoped the Assembly and community could have a discussion about a possible future administrative fee for issuing the exemption cards.

E. Questionnaire Circulated to the Public by Assembly Member Meucci

Discussion was held regarding Assembly Member Meucci's questionnaire he has circulating in the community asking for input from the public on Borough issues. Member Meucci stated the information he is gathering is for him to use regarding what issues are important to the community so that he can bring them

forward if need be. He also stated that speaking with the community is a good way to hear new ideas.
