An invitation for bids was published in the Petersburg Pilot, August 1st and 8th, 2019 to furnish 1,000 tons of 3/8 minus sand to the Petersburg Borough Public Works department. One bid was received and opened on August 15, 2019 at 1:00 pm.

Rock-N-Road Construction of Petersburg, Alaska submitted a conditional bid of \$36/ton for a minimum of 750 tons up to a maximum of 1,000 tons depending on how much sand is in their existing stockpile. A minimum of 750 tons would be delivered prior to the stipulated deadline of November 8th, 2019. They also offered an additive alternate of 500 tons at \$50/ton but were unable to guarantee delivery of the additional material prior to August 1, 2020, which is after the end of the current fiscal year's budget.

Public Works recommends award of the base bid of \$36/ton for up to 1,000 tons of 3/8 minus sand, for a total price not to exceed \$36,000. If you agree with this recommendation, please forward it to the Borough Assembly for consideration at their next regular meeting on September 16, 2019. Thank you.
