At the April 1, 2019 Assembly meeting, the Assembly granted approval for Director Hagerman to enter into negotiations with the highest ranked vendor who responded to the Borough's Request for Proposal (RFP) for supply, integration, training and support of a fully functioning radio frequency based Advanced Metering Infrastructure (AMI) system in the North Harbor, which was Eaton Corporation. Director Hagerman has completed the negotiations and is recommending the Assembly authorize entering into a contract with the Eaton Corporation for an amount not to exceed \$113,034.38 to provide a fully functional, integrated AMI system and the first year's software maintenance support.

At the time of the publishing of this agenda, it is unknown if School Bond Debt Reimbursement will be included in the State's FY 2020 budget. Unless more is known by meeting time on June 21st, the Assembly will need to decide whether or not to collect the property taxes to pay the entire portion of FY 2020 School Bond Debt in case the State reimbursement is not included in the States FY 2020 budget.

If the Assembly decides not to collect the additional property taxes immediately and the Governor vetos School Bond Debt Reimbursement, the Borough will need to borrow the monies to cover the debt from other funds and those funds must be paid back. In that case, the Borough will need to increase future mill rates to repay the loan. If this is the will of the Assembly, Resolution #2019-10 (A) should be adopted.

If the Assembly decides to collect the additional property tax in the tax bill being sent out July 1, 2019 and the Governor does not veto School Bond Debt Reimbursement, the additional taxes collected will be held until the next fiscal year's mill rate is figured and the rate will be reduced by the amount of funds already collected. If this is the will of the Assembly, Resolution #2019-10 (B) should be adopted.
