Mayor's Report For August 15, 2016 Assembly Meeting

1. Seeking Letters of Interest: The Borough is seeking letters of interest from Borough residents willing to serve on the following Boards and Commissions until the October, 2016 Municipal Election:

2. Filing for Candidacy for the October 4, 2016 Election: The first day to file for candidacy for any open board, commission or Assembly seat in the October election was July 26, 2016. Packets are available for pick-up at the front desk of the Borough municipal offices in the PIA building or by downloading from the Borough website. Completed forms must be returned to the Clerk's office by 5:00 pm on August 23, 2016.

The following **19 seats** are up for election:

As of Friday, August 12, 2016, the Clerk's office had received **five** total declaration of candidacy forms: one for the Mayor's seat, one for an Assembly seat, one for a School Board seat, one for a Planning Commission seat, and one for a Library Board seat. **5 out of 19 is only 26%** - Borough Clerk Thompson encourages all qualified Borough voters to take part in our Borough government by running for an empty seat on one of our boards or commissions. - 3. Seeking Community Input on State Dock Issue: The State of Alaska has offered to transfer ownership of the Papke's Landing dock, the Kupreanof dock, and the Entrance Island dock to the Petersburg Borough along with a lump sum payment of \$732,883 toward deferred maintenance. Condition assessments were recently performed that estimates the cost to bring the Papke's Landing dock to a safe and usable condition at \$1,050,000 and \$1,395,000 for the Kupreanof dock. The Borough Assembly is still seeking input from the community regarding acceptance or denial of the State's offer. A questionnaire on the issue is available for printing off the Borough's website (www.petersburgak.gov) or can be picked up at any Borough office, from the City of Kupreanof Clerk, or from the Papke's Landing Public Notice Board. The plan is to address this issue after the October municipal election.
