PETERSBURG BOROUGH ORDINANCE # 2015-06

AN ORDINANCE OF THE PETERSBURG BOROUGH ADOPTING THE BUDGET FOR THE FISCAL YEAR JULY 1, 2015 THROUGH JUNE 30, 2016

Section 1. Classification: This ordinance is not of a permanent nature and shall not be codified in the Petersburg Municipal Code.

<u>Section 2.</u> Purpose: The purpose of this ordinance is to set forth budgetary requirements for the operation of the various divisions, departments and organizations of the Petersburg Borough for Fiscal Year 2016. Support to the Petersburg School District has been included in the General Fund Expenditures.

Section 3. Substantive Provisions: In accordance with Section 11.07 of the Charter of the Petersburg Borough, the budget for the fiscal period beginning July 1, 2015 and ending June 30, 2016 is hereby approved in the amounts and for the purposes as stated below. The supporting line item budget detail, as reviewed by the Assembly, is incorporated as part of this ordinance.

In accordance with Section 3.01 Petersburg Borough Charter, the Levy of Taxes must be approved by ordinance. 4.24.020 of the Petersburg Municipal Code provides that there shall be assessed, levied and collected a general tax for school and municipal purposes upon all real property within the incorporated limits of the Borough. The FY 2016 Budget includes this tax. The rate of levy will be addressed at the first meeting in May by resolution once the assessment roll is certified.
