#### 7. New Business

#### a. FY20 Budget

The Borough Manager has requested that both Parks & Rec and Library cut public open hours by 8 hrs per week in the FY19/20 Budget. He is not necessarily expecting this to reduce expenses immediately but will allow us to have more flexibility in this area when we evaluate whether or not to replace positions when or if people leave. With expected revenues to continue to drop, we will need to be especially focused on where we can reduce expenses. Staff will also be taking a hard look at any programs we currently offer that take large amounts of staff time with special attention paid to those that have limited participation from the community.

#### b. Art Education Endowment Contribution

Diane Kaplan, CEO of the Rasmuson Foundation has contributed an \$8,000 CEO Discretionary Grant to the Arts Education Endowment. This comes after John McCabe, founder of the endowment, wrote her a letter telling the Foundation about the fund and inviting the Foundation to make a contribution. The balance of the fund is now \$70,218.
