Ordinance #2021-01 updates the Borough's sales tax code to allow for online payments and amends due dates and filing times.

Ordinance #2021-02: An Emergency Ordinance Approving a Loan to be Obtained by Petersburg Medical Center Through the Small Business Administration

The Petersburg Medical Center (PMC) is requesting Assembly approval to apply for a second Paycheck Protection Loan with the Small Business Administration (SBA) through a new economic relief bill passed by the U.S. Congress in December of 2020. In April of 2020, PMC applied for and received \$1.8 million through the same program and repayment of those funds has been forgiven by the SBA pursuant to the program terms. Borough Code and Charter require Assembly approval by ordinance. It is important that PMC be able to apply quickly for the loan prior to available funds being exhausted, and there is insufficient time to follow ordinary ordinance adoption procedures; therefore, an emergency ordinance, which takes one reading of the Assembly to pass or fail, is necessary.
