- A. **Petersburg Borough Public Health Mandate #5: Borough Harbor Facilities - Vessel Docking and Disembarkment**

Public Health Mandate #5 has been revised to reference applicable State of Alaska Health Advisories that were issued by Governor Dunleavy on February 14, 2021 and will require passenger vessels with interstate or intrastate travelers aboard who are subject to the recommendations to have written approval of the Borough's Public Health Officer prior to disembarking passengers or crew in Petersburg. If approved, Public Health Mandate #5 will remain in effect through May 31, 2021, unless extended or earlier terminated.

- B. **Petersburg Borough Public Health Mandate #6: Submission of Travel Plans**

Public Health Mandate #6 has been revised to reference applicable State of Alaska Health Advisories that were issued by Governor Dunleavy on February 14, 2021 and will require any business included in "Critical Infrastructure" that is intending to bring or send workers into the Borough and which submit a protective plan to the State under State Health Advisory No. 4, to simultaneously submit the plan to the Petersburg Borough for review and comment. If approved, Public Health Mandate #6 will remain in effect during the effective period of State Health Advisory No. 4, unless earlier terminated.

C. Petersburg Borough Public Health Emergency Directive #7 for Non-Congregate Sheltering

Public Health Directive #7 has been revised to remove reference to State Health Mandate #14 (which has expired). If approved, Public Health Directive #7 will remain in effect through May 31, 2021, unless extended or earlier terminated.

D. Petersburg Borough Public Health Mandate #9: Intrastate Traveler Testing

Public Health Mandate #9 has been revised to remove reference to State Health Order 6 (which has expired) and will require intrastate travelers to follow COVID-19 testing protocols when visiting Petersburg. If approved, Public Health Mandate #9 will remain in effect until June 30, 2021, unless sooner rescinded by the Borough Assembly, or until the State terminates the COVID-19 Screening and Testing Contract at the James A. Johnson Airport, whichever first occurs.

E. Petersburg Borough Public Health Mandate #10: Interstate and International Traveler Testing

Public Health Mandate #10 will require interstate and international travelers to follow COVID-19 testing protocols when visiting Petersburg. If approved, Public Health Mandate #10 will remain in effect until June 30, 2021 unless sooner rescinded by the Borough Assembly, or until the State terminates the COVID-19 Screening and Testing Contract at the James A. Johnson Airport, whichever first occurs.
