

**PETERSBURG BOROUGH
ORDINANCE #2014-21**

**AN ORDINANCE OF THE PETERSBURG BOROUGH ADJUSTING
THE FY 2015 BUDGET FOR KNOWN CHANGES**

Section 1. Classification: This ordinance is not of a permanent nature and shall not be codified in the Petersburg Municipal Code.

Section 2. Purpose: The purpose of this ordinance is to adjust the FY 2015 budget for known changes.

Section 3. Substantive Provisions: In accordance with Section 11.09(a) of the Charter of the Petersburg Borough, the budget for the fiscal period beginning July 1, 2014 and ending June 30, 2015 is adjusted as follows:

Necessary revisions in the FY 2015 budget were identified. These changes involve the increase of revenue and/or expenditure accounts. Most, but not all of the additions are grant related in which the Borough received notice of the grant award after the original FY 2015 budget was approved.
