The Assembly unanimously approved the addition of six non-capital priorities to the FY 2019 State Capital Projects List, as requested by Senator Stedman.

C. Power & Light Superintendent Recruitment

By a vote of 5-2, Mayor Jensen and Assembly Member Marohl opposed, the Assembly directed Manager Giesbrecht to cease recruitment of an Electric Superintendent and directed Clerk Thompson to revise the five ordinances necessary to restructure the utility departments (Electric, Water and Wastewater) under a Utility Director and Public Works, Motor Pool and Sanitation under a Public Works Director, as proposed by Manager Giesbrecht in May of 2017. The first reading of the ordinances will take place at the February 5, 2018 Assembly meeting.

#### 15. New Business

A. Ordinance #2018-01: An Ordinance Amending Petersburg Municipal Code Section 4.28.130, Senior Citizen Exemption, to Authorize Collection of an Application Fee in Order to Cover the Administrative Cost of Processing, Issuing, and Monitoring of Senior Citizen Sales Tax Exemption Cards
