I would like to offer my engineering services for the Design Plans & Specification Update, Contract Administration & Inspection for the New Dock Project, Adjacent to Harbor Office.

This proposal has changed from the original dated August 13, 2015. The change has to do with fact that the existing plans that were done in 2015 and need to be updated with new information. I know that one of the Borough furnished steel beams to be used in the design is gone. I believe it was used by another Borough department. The existing plans have to be redesigned with a different steel beam. The Borough supplied materials will have to be inventoried to verify they are still available. The specifications and contract documents have to be updated to reflect new dates and current information.
