I just submitted a comment via the borough website in regard to zoning code revisions that I wanted to echo here.

I think it's important to add specific language that establishes urban farms as a permitted use in appropriate locations in the Borough. Based on recent research into current zoning codes, urban farms appear to be most consistent with Commercial 1 or 2 land use designations.

Though we do not currently have commercial urban agricultural producers within the Borough, I hope to see more of this activity in the future and am investigating opening a business in the borough that utilizes hydroponic growing techniques in a climate-controlled indoor environment that would allow me to provide leafy greens, lettuce and culinary herbs year-round. I want to ensure this kind of operation is clearly allowable.

Urban farms will be an important way forward as we tackle the problem of food insecurity along with other rural communities in Southeast and throughout the state. They will provide a healthy source of local food as well as educational and economic development opportunities.
