

Borough Manager's Report Assembly Meeting 20 August 2018

- State Licensing recertification is complete for the Manor and Shelyn has submitted the Medicaid Provider recertification.
- ❖ Congratulations to Norie Steuber as our new Resident Assistant Supervisor!
- Staff recently pressure washed and grouted some areas of concrete erosion on the Cabin Creek Dam spillway.
- * Reid Brothers are working on the fabrication of the new steel superstructure for the City Creek Dam which will support the dam gate operators.
- ❖ Wastewater Staff is working on upgrades to the failed pump station at the baler and is chipping branches as they can to provide feed stock for the composting operation.
- The planned outage to repair a broken cutout and burnt cross arm went very well on August 10th. The crew was well prepared and completed the repair in 2 hours. Thanks to the public for your patience.
- The Blind Slough Hydro Evaluation project is ongoing. Staff expects to see a first draft of the conditions assessment by September.
- Crystal Lake water levels continue to drop with the dry weather. The hatchery is receiving enough water to operate but we need some rain!
- * Karl has received the land use permit from the university to allow cutting of a 50-foot power line buffer strip on their property. I'll be amending an existing contract with D&D Tree Service to include this work.
- ❖ The **SECOND** Tyee maintenance shutdown of 2018, and corresponding diesel generation run at the power plant, is tentatively scheduled for **September 6 − 9th**. SEAPA plans to inspect the Tyee Lake power tunnel with a submersible ROV and work on marker balls at Eagle River.
- The Streets crew completed some drainage improvements and resurfacing work on Marian Street and Hogue Alley. They also repaired a failed water main near the top of Fram Street.
- ❖ We are looking into options for the Borough's recycling program and gathering input from the public. So far opinions received by Public Works have been mixed as to whether the program should continue. Anyone with questions or ideas on what the recycling program should look like in the future is encouraged to share their input with the Public Works Dept.
- Chris is putting together some rehab/replacement scenarios for the solid waste baler. These will be presented to the Assembly at a future meeting.
- ❖ Julie Anderson has assumed the role of Acting Facility Supervisor and she is doing a wonderful job!
