#### 17. Assembly Discussion Items

# A. Recognitions

Mayor Jensen recognized Eric Castro for his time on the Assembly.

Member Meucci recognized Eric Castro for his time serving on the Assembly and wished Member Strand luck in the upcoming election.

B. Petersburg's Recycling Program

Member Meucci requests the recycling program subject on the October 15 meeting agenda. He would like to hear a report from Public Works Director Cotta regarding the recycling program, and would also like to discuss solid waste in general and composting.

C. Forensic Audit of the USFS Tonka and Big Thorne Integrated Resource Timber Contracts Resolution

Member Meucci requests Assembly support for consideration of a resolution that will be on the October 15 agenda regarding the USFS Tonka and Big Thorne timber contracts.

D. Appointed Assembly Representatives

Member Meucci shared his concern that when the Assembly voted to nominate Member Meucci for a seat on the Southeast Conference Board of Directors Mayor Jensen was not willing, as the Southeast Conference voting representative from Petersburg, to vote for Member Meucci's appointment to the seat. Member Meucci feels Assembly representatives should vote the will of the majority of the Assembly. Mayor Jensen stated there was no direction given by the Assembly on how he should cast his vote at the Southeast Conference meeting. Member Stanton Gregor inquired whether Mayor Jensen voted for Member Meucci and Mayor Jensen replied that he did not vote for Member Meucci.

E. Robert's Rules of Order

Member Stanton Gregor clarified that assembly members are not required by Robert's Rules of Order to second a motion for the sake of discussion. He also clarified that Robert's Rules of Order does not allow personal inneundos and that in situations where those occur, point of order can be used to halt inappropriate discussion.
