Howdy Petersburg,

I have been interested in moving down to the archipelago to escape the brutal Interior winters and enjoy more rainforest.

However I see this new Landless Tribe initiative and 5 new Corporations being formed by SeAlaska as if they want all the beach property on many islands now and it concerns me also.
